This has been a very busy year for all of us involved with the Foundation. There is still one State Award to be presented in Tasmania on 16<sup>th</sup> December involving the Premier of Tasmania.

# NATIONAL EVENTS

The highlight of the year was our National Medal event held in Brisbane on Wednesday evening 23 September 2010. The dinner was held in conjunction with the ACS as part of their 2010 World Computer Congress. Highlights of this event held at the Brisbane Exhibition & Convention Centre were:

- The 2010 Pearcey Medal was awarded to John Grant, CEO of Data #3, and Brian Finn AO together with Dr Peter Poole, were elevated to the Pearcey Hall of Fame. Presentations were made by Senator Kate Lundy who has supported our Foundation over many years
- Dr Megan Clark, CEO of CSIRO, gave the 2010 Pearcey Oration
- Over 500 people attended the gala dinner
- A provocative debate was conducted earlier in the day regarding 'Federally-funded ICT R&D in Australia' the proceedings were held under Chatham House rules
- Peter Ward was presented the 2010 Queensland Pearcey Award by Mr Robert Schwarten MP, Qld Minister for ICT

# STATE EVENTS for young innovators and entrepreneurs

The various committees in each state have worked hard to make 2010 our best year yet. Here is a quick summary of the Pearcey State Award events in date order:

- June in Victoria Brett Patterson, founder of FMOD, one of the world's leading suppliers of audio middleware used in internet games, was the winner of the 2010 Victorian Pearcey Award presented by Mr Tony Lupton MP, a Cabinet Secretary in the Victorian Government.. The event was held in conjunction with the ACS Victorian Branch (see <u>http://www.pearcey.org.au/2010\_Vic\_Award</u> for full details)
- September in the ACT awarded to Fullbright Scholar Dr Raymond Choo, a leading thinker in the burgeoning arena of cyber security. This event was also held in conjunction with the ACT Branch of the ACS as part of their annual awards evening. Senator Kate Lundy presented Dr Choo with the 2010 ACT Pearcey Award (see <a href="http://www.pearcey.org.au/2010\_ACT\_Award">http://www.pearcey.org.au/2010\_ACT\_Award</a> for full details)
- September in Queensland awarded to Peter Ward, Founder and CEO of Wardy IT Solutions, for his internationally recognised expertise and contribution to the SQL Server community. Details as per above (<u>http://www.pearcey.org.au/2010\_Qld\_Award</u>)
- October in NSW –the Rasmussen brothers of Google Map and Google Wave fame were the winners of the 2010 NSW Pearcey Award presented by Eric Roozendaal MP, Minister for State and Regional Development. This highly successful event was held as part of the NICTA@NSW Parliament technology showcase and included a provocative debate on commercialisation of ICT R&D (see <u>http://www.pearcey.org.au/2010\_NSW\_Award</u> for details)



- October in South Australia was presented to Dr Anton van den Hengel, inventor of VideoTrace, an image modelling system used in such things as Second Life and Google Maps. The event was held in conjunction with the SA Branch of the ACS (see <u>http://www.pearcey.org.au/2010\_SA\_Award</u> for details)
- December in Tasmania. As the event will be held as part of the Tasmanian Branch of the ACS' end-of-year event on 16<sup>th</sup> December 2010, there is no announcement of a winner. However, the Premier of Tasmania, David Bartlett MP, will be joining us to do just that

A couple of other interesting developments you will be interested to hear about are:

- a) CSIRO has very generously agreed to support the Pearcey Foundation for the next three years so as a National Pearcey Award for Innovation can be presented. The winner of this award, to be presented for the first time in 2011, will be drawn from the state award winners of 2010.
- b) We are hoping that Western Australia will be joining in our award scheme in 2011. The Chairman is in touch with the WAITA group via the local ACS branch watch this space!
- c) The National Committee continues to argue hard for the establishment of an ICT Economics Studies Institute dedicated to developing national policy for ICT. Essentially an academic group who potentially would have the wherewithal to undertake the recently commissioned NBN Study that was another 'one off' investigation, it is a national imperative for a services based economy like Australia's – see <u>http://wwand w.pearcey.org.au/images/a/ab/Pearcey-Proposal-DEESI-Feb2009.pdf</u> for more details as set out on our home page
